INDIAN STATISTICAL INSTITUTE ALUMNI ASSOCIATION ELECTION FOR THE TERM 2011-2013

Regulation 4.4 of Memorandum of Association of the ISIAA, inter alia, enjoins "The Executive Committee will normally remain in office for two years". The committee's tenure has since expired, it is therefore, felt expedient to complete the process of election of the new Executive Committee through a single transferable vote as per Representations of Peoples Act 1951, as amended (vide Regulation 4.3). It is also evident that the Executive Committee of ISIAA in its meeting held on 29.08.2011 has appointed Shri S.K. Iyer, Chief Executive (Admn. & Finance), Indian Statistical Institute, as the Election Officer for the purpose in term of the provision of Regulation 6.1 (iii) of the MOA of the ISIAA.

In terms of the provisions of Regulation 4.2 of the Memorandum of Association of the ISIAA, the election of the following positions is considered necessary :-

- a) Chairman
- b) Secretary
- c) Two Joint Secretaries
- d) Treasurer
- e) Five Members

viii)	Holding of elections, if necessary and announcement of the results	10.11.2011

2. A provisional list of voters will be sent on 26th September, 2011 for displaying in important Notice Boards of the Headquarters of the Institute at 203, B.T. Road, Kolkata – 700 108 and at Delhi, Mumbai, Bangalore, Hyderabad and Chennai Offices of the Institute. Reports about the inclusion, alteration and deletion of names of voter, if any, in respect of the said provisional voters' list may be submitted to the office of the undersigned within 4-00 p.m. of 10th October, 2011 facilitating the publication of the Final Voter List smooth and efficiently. All such reports should bear (1) Name in block letters and (2) Full signature invariably.
3. Excepting those who will be abroad during the election, all members whose names appear in the final list of voters will be entitled to exercise rights and privileges of a member. Attention is invited to Rule 2.2 of the Memorandum of Association of ISIAA, which, inter alia, stipulates that an associate member shall not have the right to vote in the election of office bearers and shall not be eligible to contest such an election.
