
Sub. : Announcement of final list of candidate for the Election of the President of the Institute to the Council for a two year term commencing from 18th September, 2020.

1. The last date of withdrawal of nomination for the Election of the President of the Institute was up to 4.30 p.m. of 11th August, 2020 as per Office Circular No. CAF/Elec/10-3/25 dated 16th June, 2020. Since no alternative nomination was received against the nominated candidate of the Council within the scheduled period and there was no withdrawal within the stipulated date, Shri Bibek Debroy, Chairman of the Economic Advisory Council to the Prime Minister (EAC-PM), the council nominated candidate for the said position shall stand as the only eligible candidate for the same. Therefore, it is hereby declared that there is no necessity for holding election for the office of the President of the Institute.
