OFFICE CIRCULAR

In partial modification of the Office Circular, vide No. CAF/Elec./10-3/59 dated 3rd August, 2020, regarding staggered voting to be held at Headquarters on 21st August, 2020 & 25th August, 2020 in addition to 26th August, 2020 from 11:30 a.m to 3:30 p.m. is now re-scheduled on 24th August, 2020 in lieu of 21st August, 2020, in addition to 25th August 2020 and 26th August 2020 from 11:30 am to 3:30 pm, due to announcement of Lockdown by the Govt. of West Bengal. The staggered Election at all the outlying Centres/units/ Sections/Branches etc. **except Delhi and Chennai Centres** will be held on 12th August, 2020 & 13th August, 2020 in addition to 14th August, 2020 from 11:30 a.m. to 3:30 p.m. as circulated earlier. Due to change of circumstances the staggered Election at Delhi Centre and Chennai Centre will now be held on 11th August, 2020 in lieu of 12th August, 2020 and 13th August, 2020 & 14th August, 2020 from 11:30 am to 3:30 pm.

2. Request for Postal Ballot in Form 5 (available in Institute Website for workers of Headquarters) must reach to the Election Officer on or before 14th August, 2020 (4:00 pm) and Form 5A (available in the Institute website for workers at outlying centres etc.) should reach before the Head of Centre/Unit/Office/Polling Officer of the Outlying Centres/Branches/Units/Offices etc. on or before 7th August, 2020 (4:00 pm).

3. Further, in partial modification of the Election Schedule published vide Office Circular No.CAF/Elec./10-3/21, dated 1st June, 2020, the date of counting of votes is now re-scheduled on 1st September, 2020 (Tuesday) in lieu of 28th August, 2020 (Friday) due to announcement of Lockdown by the Govt. of West Bengal.

All are requested to take note of the changes and cooperate for smooth conduct of the election.
