## ADMISSION TEST 2018

### **Verification for all MCQ-based Tests of Answer Keys, Scanned Images of OMR Answer Sheets and Recorded Responses**

All candidates who appear in the ISI Admission Test 2018 on May 13, 2018 and take any MCQ-based test(s) (UGA, PSA, MMA, PEA, PEB, QMA, PLA, LIA, HGA, GEA, DST, DCG) are hereby informed that they will be able to challenge online, for a limited period of time, the corresponding answer key as well as their own responses on OMR sheets as recorded by the OMR system if the recorded responses differ from the ones they had marked on the OMR sheet. Instructions for this will be available on the ISI Admission webpage <https://www.isical.ac.in/~admission/>.

The answer keys of all MCQ-based tests (UGA, PSA, MMA, PEA, PEB, QMA, PLA, LIA, HGA, GEA, DST, DCG) will be uploaded to the ISI website on Monday, May 14, 2018. Once this operation is completed, the challenge link will become functional, allowing candidates to challenge answers to individual questions in the test(s) taken by them for a period of 48 hours.

The scanned images of OMR answer sheets of the candidates, together with their recorded responses, will also be uploaded on the website and can be viewed by the candidates during a 72-hour period within 18/05/2018 to 22/05/2018. During this period, candidates will be allowed to challenge the recorded responses if these differ from the ones they had marked on the OMR sheet.

**Challenge fee:** The prescribed fee for each recorded response/answer key challenged is Rs. 100.00 (rupees one hundred only), plus 2.5% bank/credit card related charges, which will be required to be paid online only. If any challenge is found to be valid, the challenge fee paid will be refunded to the candidate after deduction of the applicable bank/credit card related charge.

If a challenge regarding the answer key is accepted by the Institute, that is, if any error is identified in the answer key, a policy decision will be notified on the website which will be applicable to all the candidates who appeared for the test and the challenge fee shall be refunded. Similarly, if the recorded response is not the same as marked by the candidate on OMR sheet, corrective action will be taken and the candidate's score will be updated accordingly.

#### **Please note:**

1. Challenges submitted by post or in person will not be accepted.
2. In case a candidate does not submit the challenge regarding recorded response by the prescribed date and time, it will be presumed that his/her recorded response is the same as that marked on OMR sheet.

**The Institute's decision on the challenges shall be final and no further communication will be entertained in this regard.**
