Attention to the Members who appointed in the Indian Statistical Institute on and from 01.01.2004 and those who are under the provision of New Pension Scheme may apply for loan as per decision of the Managing Committee in its meeting held on 27.02.2015, on the basis of the calculation as represented below.

Long Term Loan : Rs.40,000.00(Maximum)

Short Term Loan : Rs.20,000.00(Maximum)

Emergency Loan : Rs.20,000.00(Maximum)

OR

Long Term Loan : Rs.60,000.00(Maximum)

Emergency Loan : Rs.20,000.00(Maximum)

The maximum limit of loan in total would be Rs.80,000/-(Rupees eighty thousand) or 10(ten) times of share value whichever is less. One may eligible for maximum amount of Loan, only provided his/her minimum contribution towards monthly subscription against Thrift Fund be Rs.500/-(Rupees five hundred )only; unless the maximum loan would be limited to Rs.50,000/-(Rupees fifty thousand)or ten times of share value whichever is less.

The other rules and provision of sanctioning Loan and repayment installment will be the same.

The Members who are appointed on and from 01.01.2004 are requested to mention NPS (New Pension Scheme) on the top of the loan application form strictly.
